



## COLORADO WING SUPPLEMENT 1

### CAP REGULATION 130-2

### CIVIL AIR PATROL AIRCRAFT MAINTENANCE MANAGEMENT

CAP Regulation 130-2, dated 06 October 2023, is supplemented as follows:

**5.9.** In addition to the CAPF 71, the Wing Transfer/Inventory Checklist will be used to document aircraft transfers.

**6.11. Added.** Fully Mission Capable (FMC) – Has no discrepancies that will prevent the completion of any missions the aircraft is equipped to perform.

**6.12. Added.** Partially Mission Capable (PMC) – Has discrepancies that will limit the operational mission capability but does not pose a safety hazard to flight operations.

**6.13. Added.** Not Mission Capable (NMC) – Has discrepancies singularly or in combination that prevent completion of assigned missions, pose a safety hazard, or violate any airworthiness item.

**7.1.3. Added.** Maintenance logbooks will be stored in a locker or location approved by the Wing AMO easily accessible by pilots until fireproof containers are obtained. Copies of the aircraft maintenance logbooks entries will be scanned to the Wing Share Point Aircraft Maintenance>Powered Aircraft>Tail #>Maintenance Log file within 72 hours the following maintenance being completed: 100hr/annual inspection, mid-time oil changes, IFR certifications, oil analysis reports, and any major maintenance. Each assigned AMO will be responsible for ensuring these logbook entries are uploaded.

**7.5.1. Added.** Pilots are required to report discrepancies to the AMO assigned to the aircraft flown. The assigned AMO and pilot will discuss any discrepancies before entering the discrepancy in AMRAD and will ensure the discrepancy is documented in AMRAD at the required time. Wing AMOs will notify the Wing DO of any aircraft with a status of PMC or NMC.

**14.5.1. Added.** Summer survival kits for C-182, C-206, and GA-8 aircraft will include as a minimum the following items:

- Containment bag large enough for all listed items
- Emergency blanket (2)
- First Aid kit
- Fire starter
- Knife or multi tool
- Chem light stick (2)
- Signal mirror
- Parachute cord
- Waterproof matches
- Whistle
- Emergency drinking water
- Emergency rations

- Water purification method
- Hand warmers or gloves (2) (added to survival kit as weather dictates.)
- Emergency headgear (2) (added to survival kit as weather dictates.)

**14.5.2. Added.** C-172 aircraft may use any commercially procured survival kit.
