CIVIL AIR PATROL UNIFORM REGULATION

CAP Regulation 39-1, dated 03 March 2020, is supplemented as follows:

Paragraph # 6.1.14. Added. **Cold-Weather Parka (N2B/N3B)**. The N2B/N3B variant can be worn with all uniform combinations. For outdoor use only. The cold weather parka will be green with a fur-edged hood. When worn, the parka will be closed at all times. The hood will rest neatly on the upper back when not in use. Rank insignia is not worn on the cold-weather parka. Ref DAFI 36-2903 7.1.9.

Paragraph # 6.1.14.1. Added. Wear of the Cold-Weather Parka will be authorized when the low outside air temperature or aggregate air temperature with wind-chill is near freezing temperatures.

Paragraph # 6.1.15. Added. **Gen III, Level VII.** Provides protection similar to the N3B cold-weather parka with the fur lined hood that could be worn with all uniform combinations in an outdoor setting. Ref DAFI 36-2903 7.1.10.

Paragraph # 6.1.15.1. Added. Wear of the Gen III, Level VII will be authorized when the low outside air temperature or aggregate air temperature with wind-chill is near freezing temperatures.

Paragraph # 6.1.15.2. Added. Grade insignia will be worn with AF style uniforms. Wear of cloth name tape, "Civil Air Patrol" tape and grade insignia will be worn as outlined in paragraph 6.1.10 titled "Green Fleece Jacket"

Paragraph # 6.2.8.1. Added. Alaska Wing Baseball Cap. Alaska Wing baseball cap will be dark navy in color with the wing patch centered in the front with "Civil Air Patrol" above the wing patch. Last name or unit name may be embroidered on the back of the cap. No callsigns on the cap. The Alaska Wing baseball cap may be worn with all working uniforms to include: ABU/CFU/CWU, and FDU/CFDU.

Paragraph # 6.2.8.2. Added. Tactical Cap. Tactical cap will be dark navy in color with velcro patch centered in the front for use with 2x2 velcro fleece rank insignia. Officers and cadet officers will wear the velcro embroidered grade insignia centered in the front velcro field. Chaplains will substitute rank with chaplain insignia. Cadet airmen, senior member NCO's, and seniors without grade will not wear a grade insignia on the front. Last name may be embroidered or affixed with Velcro on the back of the cap. No callsigns on the cap. Velcro field will be free of commercial designs or logos if visible or may be removed if not used. The tactical cap may be worn with all working uniforms to include: ABU/CFU/CWU, and FDU/CFDU. (Ref DAFI 36-2903 5.2.10)

Paragraph # 6.4.3.1 Added. Cold weather boots. When conditions are appropriate for the wear of the N3B or Gen III Level VII ECWCS, and members are participating in an activity that is conducted outside in the elements, Cold weather boots appropriate to the conditions are authorized. Cold weather boots such as military-style mukluks, vulcanized rubber boots (bunny boots), duck boots or other civilian style pack boots may be worn in all working uniforms to include: ABU/CFU/CWU, and FDU/CFDU.

Paragraph # 10.9.26 Added. **The Arctic Shield Marine Safety Task Force patch** may be worn by Aircrews and Mission Base Staff supporting this recurring activity for the duration of the mission each year. Patch will be removed at the conclusion of the mission.

Paragraph # 10.9.26.1 Added. **The Arctic Shield Marine Safety Task Force patch** will be worn on the Right sleeve of the FDU/CFDU or on the Right breast pocket on the ABU/CFU. (Reference AFI36-2903 A6.4.3.5 for precedence with AF style FDU).
