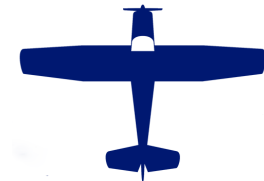

Activities (NCSAs)***

### LIFT

A summer of exploration is on the horizon! The Lift Program provides assistance for activity fees associated with NCSAs as well as travel expenses to and from that activity. Activities like National Blue Beret and National Cyber Academy are looking for cadets like you!

### TOP *Cadet Take-Off Program*

Need a Solo? National Flight Academies (NFAs) are the way to get started! TOP covers activity fees for NFAs and travel expenses to and from that activity. NFAs offer glider and powered aircraft training.

***Merit based financial assistance  
from Solo to  
Private Pilot Certificate (PPC)***

Cadet Wings is a fully-funded, CAP administered student pilot program. Cadets can apply for funding to be used at a local flight school or using CAP assets.

There is limited availability for in-residence programs through CAP Advanced Flight Academy and in partnership with Air Force JROTC.

Ideal applicants will meet the following criteria:

- Aircraft Ground Handling (current)
- Student Pilot Certificate
- FAA Medical Certificate- Class III (not needed for glider)
- Solo Endorsement-- does not need to be in the same type of aircraft, glider solo will be accepted for PPC path
- Passing score on the FAA Knowledge Test aka Written Test
- Flight Plan: A statement describing training location and timelines.

***Merit based Financial Assistance for  
Flight or Academic  
related expenses***

Each scholarship offered has its own unique requirements. We award numerous recipients for many of our scholarships that range monetarily. Others may only have one recipient.

### Academic Scholarships

Academic Scholarships can be applied to any academic related need including books, coursework, tuition, training material, etc.

### Flight Scholarships

Flight Scholarships can be applied to anything flight related including instructor fees, plane rental, flight gear, etc.

### USAFA Preparatory School

Each year, CAP National Headquarters recommends cadets for consideration. One cadet is awarded a spot in the USAF Prep School.

### School-Specific Scholarships

School-Specific Scholarships are directly tied to specific academic institutions and have their own application criteria.
