MEMORANDUM FOR ALL CAP UNITS

SUBJECT: Interim Change Letter – CAPR 130-2, *Civil Air Patrol Aircraft Maintenance Management*

1. This interim change letter immediately changes CAPR 130-2, *Civil Air Patrol Aircraft Maintenance Management* and will remain in effect until revised. Compliance with this letter is mandatory.
2. Delete the following sentences from the end of Attachment 1, Compliance Item Tab C-4 05 Discrepancy Write-up item (c) “- This aircraft is grounded for flight under Instrument Flight Rules and flight within controlled air-space until these checks have been completed. - If the aircraft must be flown to another airport for inspections, the wing/region must obtain an FAA ferry permit for that flight.”
3. Delete the following reference from the end of first sentence of Attachment 1, Compliance Item Tab C-4 05 Discrepancy Write-up item (c) “and 14CFR Part 43” and replace it with “, 14 CFR 91.411 and 14 CFR 91.413.”
4. Delete the following sentences from the end of Attachment 1, Compliance Item Tab C-4 05 Discrepancy Write-up item (d) “This aircraft is grounded pending replacement of the ELT battery. - If the aircraft must be flown to another airport to these inspections, the wing/ region must obtain an FAA ferry permit for that flight”
5. Delete the following reference from the end of Attachment 1, Compliance Item Tab C-4 06 Discrepancy Write-up item (d) “CAPR 66-1” and replace it with “CAPR 130-2”
6. Delete the following sentence from the end of Attachment 1, Compliance Item Tab C-4 06 Discrepancy Write-up item (f) “N\_\_\_\_ is grounded until the wing/region corrects the checklist/POH and properly inflates the tires on this aircraft.”
7. The intent of this change is to bring the compliance elements in Attachment 1 into agreement with guidance contained in 14 CFR.
