Aircraft Maintenance

CIVIL AIR PATROL AIRCRAFT MAINTENANCE MANAGEMENT

CAPR 130-2, dated 4 October 2021, including ICL 22-01, is supplemented as follows:

- **2.5.** Added. Aircraft Custodian. Each squadron with assigned aircraft shall appoint a Squadron Operations Officer, who shall be the Aircraft Custodian. By the 5th day of each month, Aircraft Custodians shall assure that the following tasks are performed:
 - Collect aircraft tach sheets and email copies in PDF format to the Kentucky Wing Squadron Operations Officer list, squadronops@kywg.cap.gov

Aircraft Custodians shall also be responsible for the following:

- Updating the navigation database in any assigned aircraft with an IFR GPS prior to its expiration.
- Ensuring that aircraft are washed at least bi-annually per CAPR 130-2 (para 10.4.5) and shall communicate the date of each aircraft wash to the Wing AMO for logging in AMRAD. Aircraft Custodians shall ensure aircraft are washed more often than bi-annually based on condition. Washing the aircraft includes degreasing the belly of the aircraft with a Boeing approved non-alkaline degreaser.
- Maintaining the general cleanliness & security of the aircraft and the condition of its tie downs.
- Maintain and inspect survival kits by ensuring perishable items are replaced regularly.
- 9.1 Added. The Wing AMO and Wing Asst. AMO, are the only members of the Wing permitted to interact with aircraft maintenance vendors. A pilot may be authorized to interact with maintenance vendors if directed to do so by the AMO or Asst. AMO. No other members of the Wing will contact maintenance vendors unless expressly authorized by the AMO or Asst AMO.
- 14.5.1. Added. Survival kits will be carried aboard all powered aircraft on all flights. Survival kits will contain items as listed in appendix 1.

ATTACHMENT 2 Aircraft Survival Kits.

- 1. Aircraft survival kits will contain, at a minimum, the following items:
 - 1 quart canteen with Stainless Steel Cup (empty)
 - 1 lensatic compass with carry case
 - 2 Personal size Thermal space blankets
 - 1 Commercial First Aid Kit
 - 1 Waterproof Match Box
 - 2 Boxes of Waterproof Matches
 - 1 Magnesium Fire Starter
 - 1 Snake Bite Kit
 - 1 pkg Analgesic Pain reliever (acetaminophen) (check Expiration)
 - 1 pkg Water Purification Tablets 1 Folding Multi-Tool with pouch
 - 1 Signal Whistle with Lanyard
 - 1 Signal Mirror with Carrying Case
 - 1 Hank of Parachute Cord
 - 1 Roll of Duct Tape (replace in 1st quarter of even years)
 - 1 Personal Hygiene Kit (Tempo and Wet Wipes) (replace in 1st quarter of even years)
 - a. 1 Pkg of 1 gallon Zip Loc Bags
- 2. KYWG would recommend adding the following items in personal flight kits:
 - Insect Repellant
 - Sunscreen
 - Gloves
 - Food Bars
 - "Floppy" Hat
- 3. Units may add items based on geographic location, season, and mission necessity.
