CIVIL AIR PATROL UNIFORM REGULATION

SUMMARY OF CHANGES

This supplement consolidated the Wing's wear policy when at State of Indiana or other government buildings conducting CAP business to simply use the national capital standard. INWG Ballcap described and authorized wear updated. The wear time frame for shoulder cords was adjusted. Organizational patch guidance in attachment removed and simplified in supplement.

CAP Regulation 39-1, dated 5 March 2020, is supplemented as follows:

1.2.6.4. This policy is applicable when conducting business on behalf of Civil Air Patrol in the equivalent State of Indiana or local government buildings. When necessary for the specific performance of work to be conducted, field or flight duty uniforms may be authorized by a group or higher commander if the approval is made in advance of the event.

6.2.8. CAP Baseball Cap. The Indiana Wing Ball Cap (Figure 6.16) may only be worn with Corporate Working Uniforms. The Indiana Wing Ball Cap will be dark blue with "Civil Air Patrol" scrolled above silver wings with "52" in the wing center (in the style of the Indiana Wing Patch) and "Indiana Wing" centered horizontally under the wing (gold text). The Indiana Wing patch will be centered on the rear above the adjustment.

6.2.11. Encampment Specific Headgear. Added. The Encampment Commander (ENC/CC) may authorize wear of encampment specific headgear, for encampment wear only, when approved by the wing commander. Encampment headgear will not be worn outside of the encampment training environment. Red baseball caps will not be used. Encampment baseball caps may be worn only with the BDU, ABU, and corporate field uniform. Grade will not be worn on this hat.

9.4.1.1. Cadet recipients of the following awards are authorized to wear a blue and white woven shoulder cord, without ornamentation or accessory, as prescribed in CAPR 39-1 para 9.4.1, for the remainder of the calendar year that the award was presented in and until 31 December of the following year.

9.4.1.1.1. Lt Col Russ Hollenbeck Cadet of the Year. Added.

9.4.1.1.2. David Dennis Memorial Award. Added.

9.4.1.1.3. Air Force Sergeants Association (AFSA) Outstanding Cadet NCO of the Year. Added.

9.4.1.1.4. Frank Brewer Memorial Aerospace Award – Cadet Category. Added.

9.4.1.2. Cadets participating in the Indiana Wing Cadet Executive Program are authorized to wear a blue and scarlet woven shoulder cord for the duration of their participation in the program. Cadets who complete one year of service may, upon recommendation of their mentor in the program, continue wearing the cord for the remainder of their time in the cadet program while a member of Indiana Wing.

10.9.5. Organizational Patch. Squadrons will submit organizational patches to their respective Group Headquarters. Group Headquarters will review squadron submissions. Group Commanders will submit approved subordinate unit patch designs and Group patch designs to dp@inwg.cap.gov for wing approval. INWG/DP will review the submission for completion and ensure that the design meets the guidelines published by the Air Force Historical Research Agency. INWG/DP will forward to INWG/CC for approval following this review. Additionally, AFI

84-105, *Organizational Lineage, Honors and Heraldry*, provides further guidance in patch development and design.
