

Walmart Foundation Grant Guidelines and FAQ

Range of Grants: \$250-\$5,000

Grant Cycle: Application deadline is Dec 31. The grants cycle begins February 15.

How do I get squadron access to the application portal?

When a local CAP Squadron/Flight wants to submit a Walmart Foundation Community Grant request to their nearby Walmart or Sam's Club facility(ies), they will first need to set up an account under the *singular* CAP EIN (75-6037853) and their own specific Squadron/Flight Contact Information. *This cannot be done directly by the CAP Squadron/Flight on the grant portal.*

Therefore, the personnel at the Squadron/Flight must first contact the Grant Support personnel at **Cybergrants.com** via email to request that they (Cybergrants.com) set up an account for them on the Walmart Foundation Community Grant portal.

The appropriate email to use to initiate this process is: cgsupport@cybergrants.com. The Cybergrants contact only provides the unique username and a temporary password so that one can then proceed to the next step.

What info do I include in the email to cybergrants.com?

In this email, the CAP Squadron/Flight will provide specific contact information for the personnel handling the Squadron/Flight grant application, receipt of funds if awarded, local publicity of the award, etc. This will include the contact's full name, official name of the Squadron/Flight, complete mailing address, phone number, and email address. The Cybergrants.com staff will then establish a specific username and password for that local CAP Squadron/Flight to use when it subsequently applies for a Walmart Foundation Community Grant.

Who do I contact?

Simultaneously contact the local Store Director where you will direct the grant application request *and* complete the online application. If that person is interested in supporting the CAP use of the grant, then you are 80% of the way there!

Once your application is formally submitted, the information for the proposed grant request will go to the Store Director. That's why it is important to talk to them first and get them on board with your proposal first. If the Store Director tells you that he/she won't support the request, then you need to move on to a different store in the area.

Will I receive confirmation?

A confirmation email will be sent to the requestor. The process usually takes 48-72 hours from receipt of the request.
